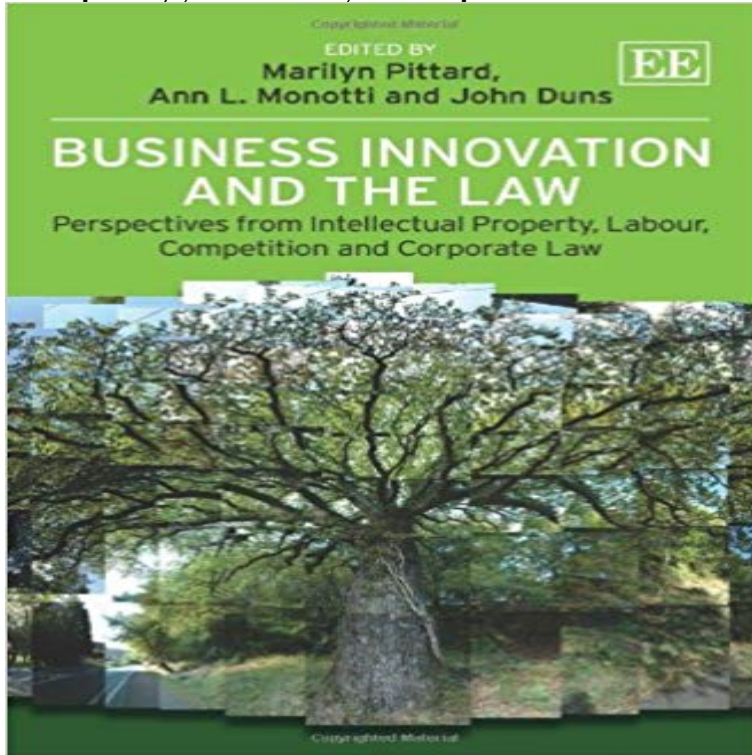


# Business Innovation and the Law: Perspectives from Intellectual Property, Labour, Competition and Corporate Law
