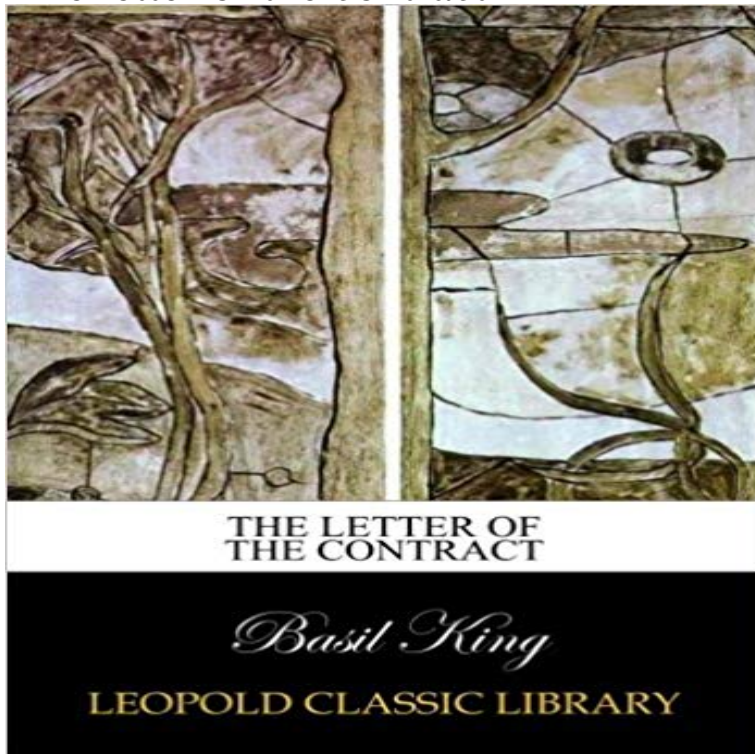


The letter of the contract
