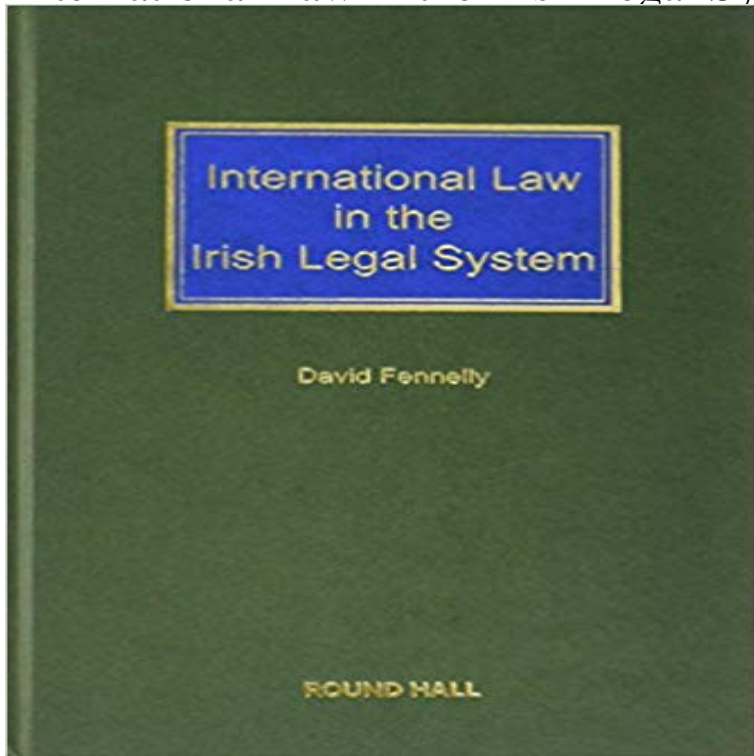


International Law in the Irish Legal System
