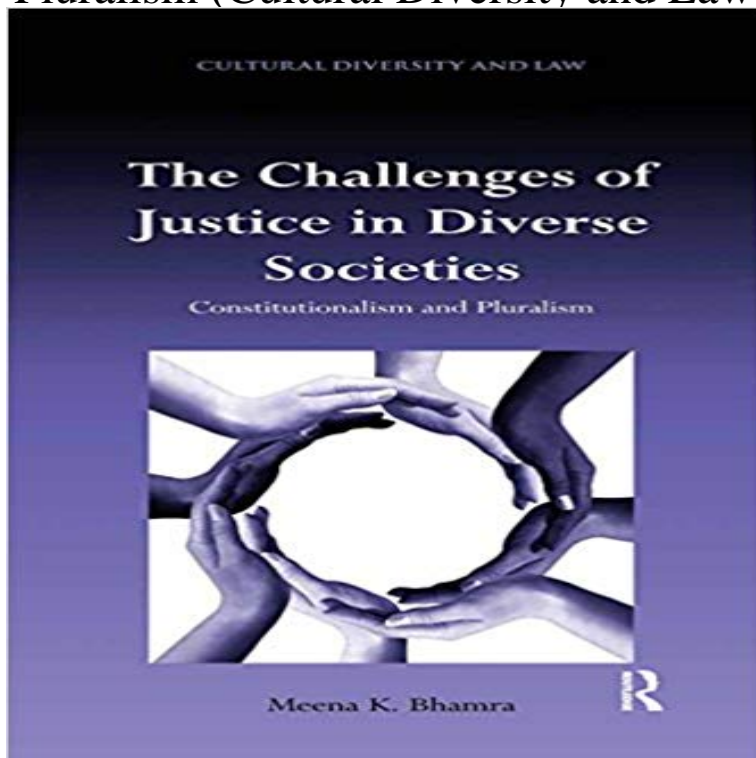


The Challenges of Justice in Diverse Societies: Constitutionalism and Pluralism (Cultural Diversity and Law)
